The Four Seasons sun parasol is a sturdy year-round design that deflects the heat of the sun and provides shelter from the rain. Made from pieces of sheet steel circling around a steel post, the base bolts securely to the ground. The central support post can remain upright or be installed to tilt away from the base at an angle of up to 86°. Once the installation is complete, the support post will remain upright or permanently titled, as the angle cannot be adjusted afterwards. Four Seasons adds a contemporary element to city gardens, food courts and open courtyards, or any environment where shelter and shade are needed.


