## **Product specification**

The WAX-LI supply air unit enables a low-pulse supply air flow necessary for smoke extraction with small supply air openings in the building. This is achieved by means of a textile distribution element placed in a wall opening which, in the event of smoke extraction, enables low-pulse supply air to be provided by means of a large surface area. The WAX-LI can be used in all systems for smoke extraction with smoke layer formation. Other applications requiring low-pulse supply air are also conceivable. The supply air is adapted by means of variable frequency drive in the range from 5000 m3/h to 25,000 m3/h at an inflow speed of max. 1 m/s. The opening in the external wall is only 1 m2. Due to the inflow from the textile distribution element used, the size of the wall opening is reduced several times over compared to a conventional supply air flow. The thermal insulation of the building envelope remains intact, the U value is 1 W/m2K, and is thus comparable to that of a commercially available window

Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.

#### Data quality:

Specific data for the product composition are provided by the manufacturer. The data represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on EPDs according to EN 15804 and different LCA databases. The data quality of the raw materials in A1 is presented in the table below.


