## **Product**

#### Product Description:

The Danvaern DV Standard serie Glass Railing Mounting Systems ensures quick and secure adjustable glass fixing. The profiles are either anodized or powder-coated to a surface quality that can be used in all outdoor environments. This system incorporates high UV protection plastics and EPDM rubber seals for longevity in various weather conditions. It is designed for easy installation while maintaining a strong, lightweight build.

#### Product specification:

The profiles are made from top-quality EN AW-6060 aluminium. 1 kilogram of product was chosen as the appropriate declared unit for the study. To obtain the impact of a specific product, the reported impacts are to be multiplied by the weight of the product installed.

- The use of cut-off criterion on mass inputs and primary energy at the unit process level (1%) and at the information module level (5%).




