Supplied as a right hand variant, but can be easily rebuilt on site to the left hand variant. The after-heating battery (electric / water) is supplied with the units and installed on site. The unit's compact physical dimensions simplifies transport and make the products flexible and adaptable to most installations. The flexibility gives cost savings in the event of changes in projects and makes it impossible to order wrong variant. The units can also be ordered pre-configured as desired, but with a certain delivery time. Easy control with Siemens Climatix by control panel ProPanel or ProTouch.

#### Allocation:



The allocation is made in accordance with the provisions of EN 15804. Energy, water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.

# Data quality:

Specific data for the product composition are provided by the manufacturer. The data represent the production of the declared product and were collected for EPD development in the year of study. 

GWP-IOBC is also referred to as GWP-GHG in context to Swedish public procurement legislation.
