Cut-off criteria:

All major raw materials and all the essential energy is included. The production processes for raw materials and energy flows with very small amounts (less than 1%) are not included. These cut-off criteria do not apply for hazardous materials and substances.

Allocation:

The allocation is made in accordance with the provisions of EN 15804. Incoming energy and water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.

Data quality:

Specific data for the product composition are provided by the manufacturer. They represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on registered EPDs according to EN 15804, Ostfold Research databases, econvent and other LCA databases. The data quality of the raw materials in A1 is presented in the table below.



System boundary:

The system includes the extraction of stone at Omya Hustadmarmor AS: Hammerfall (module A1), the transport of the stone by boat to Knarrevik (module A2), the manufacturing of Microdol 5 (module A3), and its distribution to clients (module A4).

LCA: Scenarios and additional technical information

The following information describe the scenarios in the different modules of the EPD.

Module A4 contains an average distance of transportation to the Norwegian market, with a truck of capacity higher than 32 tonnes.

Modules C and D are not relevant for this product, as it fulfills the three criteria described by EN 15804+A2:2019, namely: 1) the product is physically integrated with other materials during installation so it cannot be physically retrieved at end of life; 2) The product is no longer identifiable at end of life as a result of a physical or chemical transformation process; and 3) The product does not contain biogenic carbon.
