

Product specification

Ceiling diffusers with square diffuser face. Supply air and extract air variants for comfort zones.

Diffuser face with fixed air control blades for horizontal four-way air discharge. For installation into all types of suspended ceilings.

Ready-to-install component which consists of the galvanised sheet steel diffuser face with fixed air control blades, a diffuser front frame with perimeter seal and connecting frame, opposed action blades, butterfly damper or a plenum box.

Diffuser face suitable for central screw fixing.

Sound power level of the air-regenerated noise measured according to EN ISO 5135.

Cut-off criteria:

All major raw materials and all the essential energy is included. The production processes for raw materials and energy flows with very small amounts (less than 1%) are not included. These cut-off criteria do not apply for hazardous materials and substances.



Allocation:

The allocation is made in accordance with the provisions of EN 15804. Energy, water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.

Data quality:

Specific data for the product composition are provided by the manufacturer. The data represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on EPDs according to EN 15804 and different LCA databases. The data quality of the raw materials in A1 is presented in the table below.


