
## Data quality:

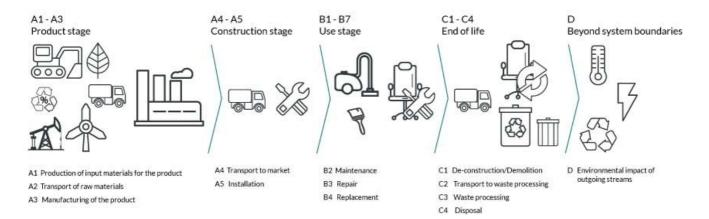
