Ready-to-commission unit which consists of the mechanical parts and the electronic control components Each unit contains an averaging effective pressure sensor for volume flow rate measurement, and a damper blade. Factory mounted control components complete with wiring and tubing Effective pressure sensor with 3 mm measuring holes, hence resistant to contamination. Position of the damper blade indicated externally at shaft extension. The damper blade is factory set to open position, which allows a ventilation airflow even without control; this does not apply to variants with defined safe position NC (normally closed). The allocation is made in accordance with the provisions of EN 15804. Energy, water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.

Specific data for the product composition are provided by the manufacturer. The data represent the production of the declared product and were collected for EPD development in the year of study. 
