Fire protection valve for the isolation of duct penetrations between fire compartments.

For use in supply air and extract air systems; with two-stage adjustment device for adjusting the air volume. Ready-for-operation unit, which includes a fire-resistant valve cone and a release mechanism. Tested for fire resistance properties to EN 1366-2, with CE marking and declaration of performance according to the Construction Products Regulation. For mortar-based installation into solid walls and ceiling slabs, and into lightweight partition walls with metal support structure and cladding on both sides.

Casing length 150 mm (300 mm with extension piece).

For the connection to ducts made of non-combustible or combustible materials.

Thermal release at 72 °C.

## **Allocation:**

The allocation is made in accordance with the provisions of EN 15804. Energy, water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.

## Data quality:

Specific data for the product composition are provided by the manufacturer. The data represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on EPDs according to EN 15804 and different LCA databases. The data quality of the raw materials in A1 is presented in the table below.


