Product description:

Ektafol PV 1.6 is a roofing membrane made of plasticized PVC, reinforced with a polyester textile. The material is enhanced with stabilizers to ensure excellent durability under exposure to extreme temperatures, UV radiation, and atmospheric pollutants. Additionally, the product offers improved fire resistance. The membranes are joined using hot-air welding, providing a strong and reliable seal.

Product specification

Ektafol roofing membranes are primarily used as exposed, mechanically fastened coverings on sloped and flat roofs. Ektafol PV is suitable for installation on all types of substrates but requires a separate migration barrier or leveling layer when applied over polystyrene substrates or during re-roofing projects.

Cut-off criteria:

All major raw materials and all the essential energy is included. The production processes for raw materials and energy flows with very small amounts (less than 1%) are not included. These cut-off criteria do not apply for hazardous materials and substances.

Allocation

The allocation is made in accordance with the provisions of EN 15804. Incoming energy and water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.

Data quality:

Specific data for the product composition are provided by the manufacturer. They represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on registered EPDs according to EN 15804, Ostfold Research databases, ecoinvent and other LCA databases. The data quality of the raw materials in A1 is presented in the table below.




