Protan InfraPlan P22+ is a homogeneous, flexible waterproofing membrane made of plasticized PVC. The product is black with a light-colored signal layer.

Protan InfraPlan is designed for functionality and versatility and can be used for waterproofing tunnels, underground structures, as well as horizontal and vertical sealing of basement foundations not exposed to sunlight.

#### **Product specification**

Protan InfraPlan P22+ is produced at the manufacturing plant P3 of Protan.

Complies with EN 13967 and EN 13491, meeting all standard requirements.

Approved as a Type II membrane according to the Norwegian Public Roads Administration Handbooks N500 and R510. Homogeneous material with a signal layer.

Not compatible with bitumen and must be protected from UV exposure.

The membrane is recyclable.

## **Cut-off criteria:**

All major raw materials and all the essential energy is included. The production processes for raw materials and energy flows with very small amounts (less than 1%) are not included. These cut-off criteria do not apply for hazardous materials and substances.

#### Allocation:

The allocation is made in accordance with the provisions of EN 15804. Incoming energy and water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.

#### Data quality:

Specific data for the product composition are provided by the manufacturer. They represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on registered EPDs according to EN 15804, Ostfold Research databases, ecoinvent and other LCA databases. The data quality of the raw materials in A1 is presented in the table below.




