Splitter with hugh inseration loss with broadband attenuation even in the low frequency range.

Sound attenuator splitters, installation kit to be used in ventilation and air conditioning systems.

Product specification

Sound attenuator splitters used for the reduction of fan noise and air-regenerated noise in air conditioning systems.

Attenuation effect due to absorption. Energy-saving as well as hygiene tested.

The installation kit consists of an aerodynamically profiled frame (bullnose radius of 20 mm) and sound absorbing material.

The splitter frame reduces pressure losses and air-regenerated noise.

The special profile helps to reduce the weight and increase the rigidity of the splitters.

Frame edges are folded to protect the sound absorbing infill. Insertion loss and sound power level of air-regenerated noise measured according to FN ISO 7235

Hygiene compliant with VDI 6022, VDI 3803 Part 1 and DIN 1946 Part 4.

Suitable for areas with potentially explosive atmospheres (ATEX), zones 1, 2, 21 and 22 (outside) according to Directive 1999/92/EC.

Cut-off criteria:

All major raw materials and all the essential energy is included. The production processes for raw materials and energy flows with very small amounts (less than 1%) are not included. These cut-off criteria do not apply for hazardous materials and substances.

Allocation:

The allocation is made in accordance with the provisions of EN 15804. Energy, water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.

Data quality:

Specific data for the product composition are provided by the manufacturer. The data represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on EPDs according to EN 15804 and different LCA databases. The data quality of the raw materials in A1 is presented in the table below.





U-sheets and clamp sheets to join subdivided attenuator splitters.
