Product

Product description:

SESU-Cable are self submerging HDPE pressure pipes with weighted peelable layer. These pipes are for cables, and are designed mainly for underwater installations. The pressure pipes are black and with grey outer layer with couloured identifications stripes to meet national requirements. This EPD covers both coiled pipes and pipes in straight lengths.

This specific EPD is for a 100 meter length black HDPE pressure pipe, 110 mm, SDR13,6, 20 % weight load in salt water, and with grey coloured peelable layer with red identification stripes.

For project specific EPD other dimensions, weight loads and colours can be included.


The allocation is made in accordance with the provisions of EN 15804:2012+A2:2019. Incoming energy and water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.

Data quality:

Specific data for the product composition are provided by the manufacturer. The data represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on EPDs according to EN 15804 and different LCA databases. The data quality of the raw materials in A1 is presented in the table below.
