PE 100-RC coextruded multilayer pipes with diffusion barrier of PBT for transfer of liquid fuels and their vapors at petrol filling stations. These pipes can be installed in trenches, in water and with trenchless technology. The pipes are black with red identification stripes. This EPD covers both coiled pipes and pipes in straight lengths.

This EPD is for black 63 mm SDR13,6 PE-pipe with red identification stripes. For project specific EPD, other dimensions and colours can be included

All major raw materials and all the essential energy is included. The production processes for raw materials and energy flows with very small amounts (less than 1%) are not included. These cut-off criteria do not apply for hazardous materials and substances.

#### Allocation

The allocation is made in accordance with the provisions of EN 15804. Incoming energy and water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.

#### Data quality:

Specific data for the product composition are provided by the manufacturer. The data represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on EPDs according to EN 15804 and different LCA databases. The data quality of the raw materials in A1 is presented in the table below.


